

## May 7th - Is this the last day for democracy in the UK?

If the recent statements made by the Conservatives, Labour, Lib-Dems and many other parties have shown anything, then it appears that the UK could remain within the EU forever.

Despite Cameron's talk about the possibility of an EU referendum, he still maintains that the UK should remain a member, but he will try to make a few changes. When he fails to get any meaningful changes perhaps he, like many leaders before him will realise that the EU has no intention of changing direction in order to allow national states any power, we must hope that he then becomes a true eurosceptic.

Ed Miliband does not see any need to consult the electorate because he only wants the UK to remain within the EU, no matter what. Luckily for Ed, Clegg appears to be of the same opinion as do most of the smaller parties. Meanwhile, the SNP wishes to break up the UK in order to make life even easier for the EU, perhaps they will get an EU grant to assist in this process!

Does it matter who governs a country?

# Customs Union redundant!

The EU Customs Union is a relic from the 1950s. It is redundant.

There are no significant customs unions anywhere else in the developed world.

\* As part of the EU Customs Union (which also includes a non-EU member, Turkey), the UK does not “own” the customs duties (also known as “tariffs”) it charges on imports of goods into the UK originating outside the Customs Union. The UK merely collects the customs duties on behalf of the EU and hands them over to “Brussels”, less a “handling fee” of

25% of the amounts collected. EU customs duties are a tax on British manufacturers and consumers.

\* Although the monetary amounts of customs duties raised are declining in real terms, a cumbersome UK/EU bureaucracy, including the application of EU “rules of origin”, is still involved in assessing and collecting them.

\* Eighty-two per cent by value of all UK imports of goods from outside the EU bore zero customs duties in 2013.

\* The overall real average UK percentage rate of duty on imports of goods from outside the EU shrank by

26% between 2002 and 2013.

\* The average rate of duty on imports of industrial goods from outside the EU was 1.28% in 2013. The average rate of duty on imports of industrial and fish products from outside the EU in 2013 was 6.77%.

\* In 2013 the only significant categories of goods from outside the EU that bore average rates of customs duty in excess of 3% were footwear and clothing.

## Regulations amended for the French

The French have been granted an extra two years to bring its budget deficit below 3% of GDP, as mandated by EU regulations.

This move by EU finance ministers was widely expected, and is the 3rd extension that France has been granted since 2009.

France’s budget deficit is expected to be 4.1% of GDP this year, as it

struggles with high unemployment.

Many critics unsurprisingly, have warned that the extension undermines the EU’s market credibility.

The 3% deficit rule was brought in for euro membership, perhaps France should leave the euro until it gets its finances under control!

Meanwhile Greece is charged a high rate of interest on its loans to keep the

country afloat whilst at the same time trying to remain in the euro. The Greek people are still under the illusion that membership of the eurozone is worth having despite also having the highest levels of unemployment in the eurozone.

How Greece can afford this membership appears not to have been thoroughly costed.

*'...critics are too quick to blame the European Court of Human Rights for the expansion of the scope of the convention rights, when the evidence shows that it is actually the UK domestic courts which are largely responsible for this, together with a supine attitude on the part of successive British governments...'*

Human rights law has been hijacked in the UK by special interest groups seeking to advance their own rights above those of the rest of the population. The European convention

has been repeatedly used in a way that weakens the government's ability to defend the country from terrorism or to deal with illegal immigrants. But, while there has been a growing clamour for this abuse to be tackled, the real cause of the problem has been fundamentally misdiagnosed.

In this forensic study, barrister Michael Arnheim shows how critics are too quick to blame the European Court of Human Rights for the unwarranted extension of the convention's reach across UK law. In reality, it is Britain's domestic courts that are largely responsible for this development, while successive

governments have been too supine to prevent it happening. Given this misunderstanding of the problem, it is little surprise that current proposals to address it are misguided too. Dr Arnheim details how we have come to this pass and what must be done to address it.

## Government rules out a referendum on an English Parliament

In response to a written question from the independent Labour Peer, Lord Stoddart of Swindon, Lord Wallace of Saltaire, for the Government, has emphatically ruled out a referendum on whether there should be an English Parliament. He said: 'The Government has no plans to hold a referendum in England to ascertain the level of support for an English Parliament'.

Commenting on the Government's response, Lord Stoddart said: 'It is an insult to all English people and especially English voters. Almost on a daily basis they hear how the SNP is going to govern England from Holyrood. The English have looked on while Scotland has had its referendum but continue to be denied their own referendum on this important question.

They are not second class citizens and deserve to have equal status with the Scots.

'The temperature needs to be raised on this issue and I would advise voters to get in touch with their local candidates at this General Election, to seek a promise that they will vote for a referendum on whether there should be an English Parliament.'

# A real future outside the EU

In trade terms, the North American Free Trade Area (NAFTA) - USA, Mexico and Canada - is approximately the same size as the EU.

Mexico's exports to NAFTA in 2013 were 70.3% and Canada's 79.6%.

We are constantly told that because maybe 45% of our exports go to the EU, that is in itself sufficient reason for

the United Kingdom to be in the EU political union. However, no serious person has put forward that Canada and Mexico as a result of these exports should be in a political union with the USA.

The USA has border posts between Canada and Mexico even though they are NAFTA members, that is because,

although a successful trading bloc, there is no free movement of people, *none* at all. This proves that you *can* trade successfully *without* Free Movement of People, a pity the UK Prime Minister thinks differently.

The UK has been a leader in International Trade, long before the EU was even thought of.

The table above shows the value of trade between 20 countries outside the EU in 2013. The value 2.593 trillion euros was worth more than the entire economy of France 2,06 trillion and the UK 2.14 trillion euros respectively.

It is also important that 6 of the top 10 - indeed 11 of the top 20 trading countries - do NOT have a trade agreement with the EU. These countries trade with the EU, within the framework and under the rules of the World Trade Organisation. This is one option for the UK after exit and one the EU cannot block.

Many assume that an EU member state will inevitably export more per head of population to other member states than a country which is not a member, this is not true.

Switzerland has consistently exported to the EU a multiple per head of what we manage in the UK. The average is over four and a half times. The point is a country does not have to be in the EU in order to trade with it and trade successfully.

Now to "influence", EU membership is often justified on what they call "influence". What are the facts EU Commissioners - originally the UK appointed 2 out of 13 in 1973, 15.4% , in 2013 1 in 28, 3.6%.

What about MEPs in 1979 - 81 out of 410 - 19.8%, after the 2014 election - 73 out of 751 - 9.7%.

What about the Council of Ministers, in 1973 the UK percentage of the vote was 17.0. from 1st July 2013, post Croatia accession became 8.2%. The UK has tried to block proposals from the EU Commission to the Council 55 times, it has failed in every case.

We have therefore, no meaningful "influence", and each new member state dilutes our influence. Bizarrely, and against our national interest, the three establishment parties are all cheerleaders for more countries to join the EU. They even want Turkey with a population of up to 80 million.

Back to trade, when we exit the EU, we regain our ability to renegotiate our

own trade agreements for ourselves. Switzerland, a country with an economy one quarter the size of the UK's negotiates its own trade agreements.

The EU has trade agreements, which Switzerland does not have, with Algeria, Andorra and San Marino. Switzerland has trade agreements, which the EU does not have, with Canada, China and Japan. It is not just Switzerland.

Chile, New Zealand and Iceland, unlike the UK even negotiate their own trade agreements and all have trade agreements with China. By comparison, the EU does not.

On trade, it is crystal clear - indeed, as with everything else - UK exit is the best way forward for the future of our country.

At the present time, our commerce, business and industries are hampered by alien regulation. Our English Common Law is made inferior to the rulings of foreign court and EU directives hobble the NHS and others.

## The EU is interfering in the British general election

Dear Sir,

Does the EU have the right to interfere in the British general election, let alone try to influence the outcome? Right now that's a very good question because that is what it is doing.

The EU was responsible for much of the funding of three programmes recently broadcast on two British television channels. All three attempted to demean anti-EU opinion in the UK. Two also set out specifically to undermine support for UKIP. Not their business at any time, you might think, let alone in the run-up to a general election.

But the bureaucrats in Brussels clearly don't care a fig about what is right and acceptable and what is not.

Anyone who saw the two programmes broadcast on Channel 4 earlier this month (March 2015) mocking UKIP, or the one on the BBC a week later claiming that leaving the EU would be a disaster for the UK, will know the viciousness of the scorn poured over British anti-EU opinion on prime-time television.

Only in the small print of the closing credits was there any indication that the EU was directly behind such outrageous interference in Britain's internal affairs at a crucial time in our democratic process.

Channel Four's "*UKIP: The First 100 Days*" was funded by Culture, an EU funding agency which is, and always has been, an integral part of the European Commission's long-term financial programme to gain public support.

As recently as last December Culture was openly advertising the provision of up to 500,000 Euros each from the EU's bottomless pit of taxpayers' funds to any "creative and cultural organisations" needing to fund the "co-development, co-production and programming" of new ventures.

Of course, funding of the BBC via

the EU's Investment Bank has been known for many years. See; "*In my memoirs as an MEP*" - *A Mote in Brussels' Eye* - I reported the admission by Margot Wallstrom, the Swedish Commissioner for Communications, finally prised out of her after years of obfuscation, that the BBC had received over 100 million Euros from the EU up to 2009.

I have no reason today to think anything much has changed. Indeed, the EU made no attempt to hide its funding of the BBC's "*The Great European Disaster Movie*". The producer Annalisa Piras, a left-wing Italian journalist based in London, advises both the BBC and *The Guardian* on European affairs. She has worked closely with Bill Emmott, formerly editor of *The Economist*, on other films produced by Emmott's Springshot Productions, as indeed was this one.

According to the credits, funding came from a least half-a-dozen public service broadcasters in Europe. The leading financial backer was Arte, the Franco-German Euro TV Channel founded in 1991 in Strasbourg (were else?) by Helmet Kohl, Francois Mitterrand and others. They have been busy ever since peddling pro-EU rhetoric all over the continent. The BBC's programme was merely the latest.

Then, even more recently, Channel 5 broadcast a supposed documentary, "*Farage Fans and UKIP Lovers*". The credits appeared to suggest this was an internal production, but the content suggested an EU finger in the pie somewhere. The programme's research team had gone to great lengths to find a handful of truly odd-ball nutters, including an overweight nurse into bondage and self-flagellation, an arrogant old bachelor with verbal diarrhoea, a lesbian couple with four children, and a heavily tattooed toy soldier fanatic of truly weird appearance. Yes, we also heard from a London cabbie, a blind ex-serviceman,

a classics graduate, and two Asian businessmen - all in the name of what producers call 'balance'.

But Channel 5's purpose was obvious. Most UKIP supporters are extremists and weird-dos. Only a trawler fisherman and his crew provided any serious - and valid - contribution to UKIP's case for leaving the EU. And they did it well. More like that and the programme might have been worth watching. Instead it was a worthless lampoon.

So was the EU involved? Could Channel 5's producers have resisted the EU Culture fund's offer of half-a-million Euros to help finance a programme ridiculing UKIP? No chance. Channel 5 is a commercial channel after all. Apart from anything else, lower costs equal higher profits.

Three major UK television channels - Channel Four, the BBC and Channel 5 - all setting out to ridicule UKIP. And the EU openly funding at least two, and probably all three of them.

The question stands. What business is it of the EU, either directly or via one of its many funding vehicles, to seek to interfere in, let alone influence, the outcome of a general election in a sovereign state?
